I hereby irrevocably give an instruction (such instruction set out in this form, **"Confirming Instruction"**) to Hong Leong Finance Limited (**"HLF"**) to request that HLF carries out my previous or future Electronic Instruction to make an outgoing digital transaction or all previous and/or future Electronic Instructions from me to make outgoing digital transactions (as the case may be) (such previous and/or future Electronic Instruction or Electronic Instructions, **"Previous/Future Instruction(s)"**). I represent and warrant that the details set out above in this form are accurate, complete and authentic in relation to the Previous/Future Instruction(s).

I hereby irrevocably authorise Hong Leong Finance Limited (**"HLF"**) to act on my Confirming Instruction from the date of this form and agree to be bound by any action HLF may take, in its sole discretion, in relation to my Confirming Instruction. Any risk of misunderstanding, error, loss, damage or expense resulting from the foregoing is entirely mine, and HLF or any of its agents, or any officer, director, agent, servant, or employee thereof shall not be liable therefor.

Waiver of Liability and Indemnity

I hereby agree to indemnify, defend and hold harmless HLF, its agents and all directors, officers, employees, agents, servants and representatives thereof (referred to as **"Indemnified Persons"**) from and against any and all losses, damages, claims, costs, fines, expenses, charges, proceedings and all other liabilities whatsoever including legal costs (on a full indemnity basis) which any Indemnified Person may suffer, incur or sustain, or which may be instituted, made, brought, threatened, alleged or established against the Indemnified Persons, by any person and which in any case arises (whether directly or indirectly) out of, in relation to or by reason of:

- (a) the funds in my Account and designated by my Confirming Instruction being transferred to unintended or fraudulent parties (including any direct, indirect, incidental, special, consequential or punitive damages or economic loss or any claims for damage to property, loss of profits or loss of use) regardless of whether the fraudulent activity was known or unknown to me at the time of the Confirming Instruction and/or Previous Instruction(s);
- (b) any negligent and/or reckless act or omission, or any fraud, wilful default or wilful misconduct on my part;
- (c) my breach of or failure or delay in complying with any applicable laws, including any rules, code of conduct and/or guidelines issued by any governmental, administrative or regulatory authority or agency;
- (d) my breach of or failure or delay in complying with these terms;
- (e) anything done or omitted to be done by the Indemnified Persons pursuant to or in connection with the Confirming Instruction;
- (f) the preservation or enforcement of HLF's rights as a result of my noncompliance with any of these terms;

- (g) any claims brought or threatened by a third party against any of the Indemnified Persons from the circumstances specified in above sub-clauses of this clause or any claims, causes of actions or demands by such third parties arising out of or in connection with the performance of these terms.

In addition, I waive any right to pursue any claim, dispute, or complaint against HLF, its agents and all directors, officers, employees, agents, servants and representatives thereof for any loss, damage, or harm resulting from my Confirming Instruction (including any direct, indirect, incidental, special, consequential or punitive damages or economic loss or any claims for damage to property, loss of profits or loss of use). For the avoidance of doubt, this waiver applies to any claims made by me, including but not limited to claims of fraud, financial loss, or any other grievances arising from my Confirming Instruction.

Personal Data

I hereby consent to the collection and use by Hong Leong Finance Limited (“**HLF**”) of the personal data provided through and in connection with this form (including those of third parties, if any) in accordance with HLF’s Data Protection Notice at the Portal, the Account Terms, the Guidelines and any other terms and conditions notified by HLF.

HLF may (but shall not be obliged to) initiate and take any action or proceeding or otherwise against me in Singapore or elsewhere as HLF in its discretion deems fit, and/or take concurrent legal proceedings in more than one country.
