

# First to Grow, First to Win @ PCM

#### **Terms and Conditions**

These Terms and Conditions ("T&Cs") govern the **Hong Leong Finance ("HLF") SME@PCM** ("Campaign"). By participating in the Campaign, participants agree to be bound by these T&Cs.

# 1. Campaign Period

1.1. The Campaign runs from **15th December 2025 to 15th March 2026**, or such other period as may be determined by HLF at its sole discretion.

## 2. Eligibility

- 2.1. The Campaign is open to applicants who:
- a. Apply for a **BizCap Working Capital Loan ("WCL")** or a **Commercial Property Plus Loan ("CPPL")** at the **SME Centre @ Punggol Coast Mall (PCM).**
- b. Meet the minimum qualifying loan amount of S\$100,000.
- c. Rewards are allocated on a **first-come**, **first-served basis** based on the **date of loan acceptance**, provided that the loan is **fully disbursed** no later than **30 June 2026**.
- 2.2. All information provided in the loan application and acceptance documentation must be accurate, complete, and up to date.
- 2.3. HLF reserves the right to verify the eligibility of all participants.

#### 3. Campaign Mechanics

- 3.1. This promotion operates strictly on a first-come, first-served basis. The order of eligibility will be determined by the **date and time of loan acceptance**, **subject to the loan being fully disbursed by 30 June 2026**.
